Therefore, Candidates who have been selected under NRI/OCI quota to TNNLU for the academic year 2020-21 are directed to upload the required documents and fees paid details onto Google form which is available in the TNNLU website for formal admission. The Google form will be available in the TNNLU website from 10.00 AM to 5.00 PM on 17.10.2020.
