## NOTIFICATION FOR DIRECT ADMISSION TO LL.M., PROGRAMME

1. Corporate and Securities Laws
  2. Intellectual Property Laws

Applications are invited from interested candidates for direct admission to the few remaining vacant seats available for the Academic Year 2020-2021 for the LL.M., programmes. Few Vacant seats are available in the various categories, subject to variation.

Candidates should have appeared in the Common Law Admission Test (CLAT) 2020. Admissions will be made solely on the basis of the CLAT score. The candidates may apply directly to Tamil Nadu National Law UNIVERSITY (TNNLU) through the online application form (with payment of Rs.500/- towards application processing fee) available on the website ([www.tnnlu.ac.in](http://www.tnnlu.ac.in)) which is displayed under the caption '**Application for PG -Direct Admissions 2020**' on or before 11.59 p.m. on 17.10.2020.

The Merit list will be published in the website of TNNLU on 20.10.2020.

### Eligibility

1. Three/Five years B.L. or LL.B. or B.L.(Hons.) or LL.B. (Hons.) or its equivalent with not less than fifty five percent (55%) marks in case of candidates belonging to Unreserved/Backward Classes (Others) (BC(O))/Backward Classes (Muslim) (BC(M))/Most Backward Classes (MBC)/Denotified Communities (DNC)/Specially Abled Persons (SAP) and other categories, and Fifty percent (50%) marks in case of candidates belonging to SC/ST category.
2. The applicant should be a candidate who participated in the CLAT-2020.
3. The candidates who have scored a rank higher than the CLAT rank as indicated against the following category wise ranking are only eligible to apply:

- \* Candidates belonging to Tamil Nadu State SC/ST/Converted Christian Scheduled Castes categories need not pay tuition fee for admission, since the Government of Tamil Nadu has instructed that the tuition fee (Rs.55,000/-) should not be collected from the Tamil Nadu SC/ST students.
- \*\* In the event of **discontinuation**, the student has to remit the tuition fee of Rs.55,000/- since the Tamil Nadu Government will not pay to TNNLU in respect of students who discontinued the programme.

\*\* All Candidates are informed that the User Charges of Rs.82,000/-(Rupees Eighty two thousand only ) shall be collected after the campus reopens in proportion to the remaining Academic Year 2020-2021.
