Applications are invited from interested candidates for direct admission for a few vacant seats available for the Academic Year 2018-2019 for B.A. LL.B (Hons.) / B.Com. LL.B (Hons.) degree programmes. Vacant seats available are as follows.

- TN MBC - Tamil Nadu Most Backward Community

Candidates should have appeared in the Common Law Admission Test (CLAT) 2018. Admissions will be granted solely on the basis of the CLAT score. The candidates may apply directly to Tamil Nadu National Law School (TNNLS) in the online application form (without any enclosure or payment) at website (www.tnnls.ac.in) which is displayed under the caption 'Application for Direct Admissions 2018' on or before 05 July, 2018 by 11.59 P.M.

The Merit list will be published in the website of TNNLS on 06 July, 2018

ELIGIBILITY

1. Pass in Higher Secondary (10+2) / CBSE / other examination recognized as equivalent thereto with not less than Forty Five percent (45%) marks in case of candidates belonging to Unreserved / Backward Classes (Others) (BC(O))/Backward Classes (Muslim) (BC(M))/ Most Backward Classes (MBC)/ Denotified Communities (DNC) / Specially Able Persons (SAP) and other categories, and (40% in case of SC/ST candidates).
2. The applicant should be a candidate who participated in the CLAT-2018.

PROCESS OF ADMISSION

The following documents should be submitted at the time of direct admission.

1. Three Passport Size Photographs (recently taken photographs)
2. Payment towards first year tuition fees and other fees (Rs.2,23,000/- for General Category, and other than SC/ST Category (All India and Tamil Nadu candidates), Rs.1,17,000/- for Tamil Nadu State SC/ST Category and Rs.2,17,000/- for SC/ST Candidates other than Tamil Nadu State SC/ST Category).*
3. Payment of Rs.500/- towards Eligibility Certificate (If applicable) (Applicable to those passed HSC in other than Tamil Nadu State Board Examination.)*
4. CLAT-2018 Score card.
5. CLASS X Standard Examinations Mark-Statement
6. CLASS XII Examinations Mark-Statement
7. Transfer Certificate issued on completion of Class XII Course
8. Conduct Certificate issued on completion of Class XII Course
9. Community Certificate [for those selected on the basis of the reservations]
10. Nativity Certificate [for those selected under Tamil Nadu Resident category]
11. Evidence for 'Specially Aabled Person(SAP)', if selected under SAP Category
12. Medical Fitness Certificate [recently obtained from a Government Medical Officer]

Students are also instructed to submit self attested copies of relevant Documents /Certificates at the time of admission in TNNLS.
